#### Overview

The Kaiser Permanente San Jose PGY2 Psychiatric Pharmacy Residency Program provides a comprehensive learning experience in a variety of areas related to mental health. Training experiences include rotations in the Inpatient and Ambulatory Care settings. In addition to working closely with preceptors, physicians, and patients to become an integral part of the psychiatric care team, the psychiatric pharmacy resident will work closely with psychiatric medical residents; coupling together as a team during specific psychiatry rotations to enhance the depth of the pharmaceutical and the didactic learning experience.

The Kaiser Permanente San Jose PGY2 Psychiatric Pharmacy Residency Program provides an innovative, challenging and dynamic learning environment to its residents. Residents will experience caring for patients with a wide range of mental health conditions such as depressive disorders, anxiety disorders, insomnia, ADHD, neurocognitive disorders, bipolar disorders, substance use disorders, and psychotic disorders.

Residents who successfully complete the PGY2 Psychiatric Pharmacy Residency Program will be prepared for advanced patient care, academia, or other specialized positions, along with board certification in psychiatric pharmacy.

#### Qualification Requirements

All applicants must meet the following criteria in order to qualify for acceptance as a Kaiser San Jose Pharmacy Resident:

- Graduate of an ACPE accredited college or school of pharmacy or equivalent
- Completion of an ASHP-Accredited PGY1 Pharmacy Residency Program prior to start date in position or have equivalent experience approved by ASHP.
- Licensed as a pharmacist in the state of CA or licensed as an Intern Pharmacist in the state of CA by start of program.
- Must be licensed as a pharmacist in the state of CA by August 1, 2022.

  1. Application / Letter of intent
  2. Curriculum Vitae
  3. Three letters of recommendations in the PHORCAS application
  4. Official copy of a college transcript sent directly from the applicant's school of pharmacy to PHORCAS
  5. Submission of application by due date as indicated on PHORCAS (Pharmacy Online Residency Centralized Application Service: <https://portal.phorcas.org/>)

## Salary and Benefits:

- Kaiser Permanente San Jose Medical Center has 2 positions available in the PGY2 Psychiatric Pharmacy Residency Program.
- The twelve-month long PGY2 Psychiatric Pharmacy Residency will begin approximately on July 5, 2022 and run through approximately June 30, 2023.
- Stipend: \$33.70/hr, payroll is every 2 weeks (~\$70,000 annually)
