

# Kaiser Permanente San Diego PGY1 Community-Based Pharmacy Residency



## CORE ROTATIONAL

### MEDICATION THERAPY MANAGEMENT

The resident will be responsible for managing medication therapy for patients with chronic disease states, disease state education, and completing comprehensive medication reviews (CMRs) and targeted medication reviews (TMRs).

### ORIENTATION

The resident will become familiar with the expectations of the PGY1 CPRP, KPSD policies and procedures, receive training on electric health record, information management, research design and become acquainted with their role in the pharmacy team.

### TRANSITIONS OF CARE

The resident will perform clinical review of hospital patient charts to ensure appropriate medications are ordered at the time discharge. The resident may also perform a medication reconciliation upon admission to our contracted hospital and/or at the time of discharge.

### DRUG UTILIZATION MANAGEMENT

The resident will be responsible for identifying and resolving medication therapy issues. In addition, the resident will evaluate new drugs for possible addition the formulary and present these evaluations to the P&T Committee.

### HOME INFUSION PHARMACY

The resident will be responsible for identifying and resolving medication therapy issues and will work directly with the home infusion pharmacy team in the management of their patients.

## PROGRAM OVERVIEW



The Kaiser Permanente, San Diego PGY1 Community-Based Pharmacy Residency Program develops pharmacists with knowledge, skills, and abilities as defined in the educational competency areas, goals, and objectives. Our program is 52 weeks in duration and is accredited by ASHP in conjunction with APhA.

## CORE LONGITUDINAL

### RESIDENCY RESEARCH PROJECT

The resident will formulate a question, creating a study design, conducting literature searches, performing a pre-study if necessary, conducting the actual study, and interpreting the data collected

### COMMUNITY- BASED PHARMACY

The resident will be analyzing community pharmacy workflow from a strategic perspective. The rotation requires the resident to evaluate productivity, staffing, and identify opportunities to increase efficiency.

### COMPLETE CARE MANAGEMENT

The resident will provide disease state management for patients' chronic conditions, focusing on selecting, initiating, modifying therapy where clinically appropriate, and establishing extended patient care relationships.

### COMMUNITY OUTREACH

Through the participation and design of community outreach events with the healthcare team, the resident will become proficient in delivering patient care services to a diverse range of patients.

### MEDICATION SAFETY

The resident will develop proficient skills in identifying, developing, and implementing safe medication use practices to minimize the risk of adverse drug events.

### EDUCATION

The resident will strengthen their didactic skills through participation in teaching activities that foster the development and refinement of their communication skills, confidence, and effectiveness as a preceptor.

### ADMINISTRATION

The resident will focus on creating a business plan, financial management, regulatory compliance, business practice, quality and service management, health care environment and leadership skills development.

## ELECTIVE ROTATIONAL

The resident will have the opportunity to customize their residency schedule by selecting two elective learning experiences offered through our Kaiser Permanente ambulatory clinics. Each elective lasts 5 weeks.
