Overview

PGY2 residency programs build upon Doctor of Pharmacy (PharmD) education and PGY1 pharmacy residency training to develop pharmacist practitioners with knowledge, skills, and abilities as defined in the educational competency areas, goals, and objectives for advanced practice areas. Residents who successfully complete PGY2 residency programs are prepared for advanced patient care or other specialized positions, and board certification in the advanced practice area, if available.

The Kaiser Permanente San Jose PGY2 Psychiatric Pharmacy Residency Program provides comprehensive learning experiences in a variety of areas related to mental health. Training includes learning experiences in the inpatient and ambulatory care settings. In addition to working closely with preceptors, physicians, and patients to become an integral part of the psychiatric care team, the psychiatric pharmacy resident will work closely with psychiatric medical residents; coupling together as a team during specific psychiatry learning experiences to enhance interdisciplinary collaboration as a trainee and for the future.

Qualifications and Application Requirements

All applicants must meet the following criteria to qualify for acceptance as a Kaiser San Jose PGY2 Psychiatric Pharmacy Resident:

- Graduate of an Accreditation Council for Pharmacy Education (ACPE) accredited college or school of pharmacy or equivalent
- Completion of an American Society of Health Systems Pharmacists (ASHP)-Accredited PGY1 Pharmacy Residency Program prior to the PGY2 Psychiatric Pharmacy Residency Program start date or have equivalent experience approved by ASHP
- Licensed as a pharmacist in the state of CA or licensed as an Intern Pharmacist in the state of CA by the start of residency program
- Must be licensed as a pharmacist in the state of CA by August 1, 2024
- Candidates must be registered in the National Matching Services, Inc. (NMS)
- Candidates must participate in the ASHP Matching Program

Application Process and Deadline

1. Statement of Interest / Letter of intent
2. Curriculum Vitae
3. Three letters of recommendations in the PHORCAS application (1 from a PGY1 Pharmacy Residency Program Director)
4. Official copy of a college / school transcript sent directly from the applicant's college / school of pharmacy to PHORCAS (showing graduation date on the transcript)
5. Submission of application by due date as indicated on PHORCAS (Pharmacy Online Residency Centralized Application Service: <https://portal.phorcas.org/>)
6. Program NMS Code: 606166
7. ASHP Program Code: 92956
8. **Application Deadline: January 8th, 2024, at 11:59 pm eastern standard time**

Salary and Benefits

- Kaiser Permanente San Jose Medical Center has 2 positions available in the PGY2 Psychiatric Pharmacy Residency Program.
- The twelve-month long PGY2 Psychiatric Pharmacy Residency will begin approximately on July 1, 2024, and run through approximately June 27, 2025
- Stipend: ~\$34.32/hour, payroll is every 2 weeks (~\$71,000 annually)
