**PGY1 Managed Care Pharmacy Residency Program Purpose: To build upon the Doctor of Pharmacy (Pharm.D.) education and outcomes to develop pharmacist clinicians with diverse patient care, leadership and education skills who are eligible for board certification and postgraduate year two (PGY2) pharmacy residency training. A managed care pharmacy residency will provide systematic training of pharmacists to achieve professional competence in the delivery of patient care and managed care pharmacy practice.*

Kaiser Permanente Mid- Atlantic States Managed Care Residents will gain competence in a variety of practice areas within an integrated managed care organization. Customized training will include experiences in: benefits design and application, informatics/ systems support and integration, formulary and drug use management, quality, medication safety and compliance, primary care, medication therapy management (MTM), drug distribution, leadership development and optional teaching certificate program. Upon completion of the program, residents will be able to function independently in a variety of ambulatory and managed care settings.

Important Dates

- **January 2: Application deadline**
- July: Residency start date
- Pharmacy licensure required in Maryland and Virginia for all Residents. Primary licensure is required within 3 weeks of the residency start date and licensure in the alternate location, either Maryland or Virginia, is required within 90 days of the start date. DC licensure is strongly encouraged.
- A Pharmacy Intern license in Maryland, DC or Virginia is required by the residency start date if you do not already have Pharmacy licensure by the start date.

Program requirements

- Doctor of Pharmacy degree from an ACPE-accredited School of Pharmacy
- Pharmacy licensure in both Maryland and Virginia
- Registration in the National Matching Services, Inc. ASHP Resident Matching Program
- Kaiser Permanente Program Code for Managed Care Program: **2550**

STEP ONE

Gather your application materials:

- Letter of interest
- Curriculum vitae
- Pharmacy School transcripts
- Three letters of recommendation, letter format preferred
- One written reflection answering each of the following questions in 200 words or less:
 - Describe one of your most recent interventions or contributions on rotation, and what you learned from the experience.
 - How does a Managed Care Pharmacist contribute to the Healthcare system?

STEP TWO

Submit all documents to the PhORCAS website: **ashp.org/phorcas**.

Application materials must be received by January 2.

STEP THREE

Interview required on-site.

STEP FOUR

Rank your Residency Program preference through the National Matching Service.

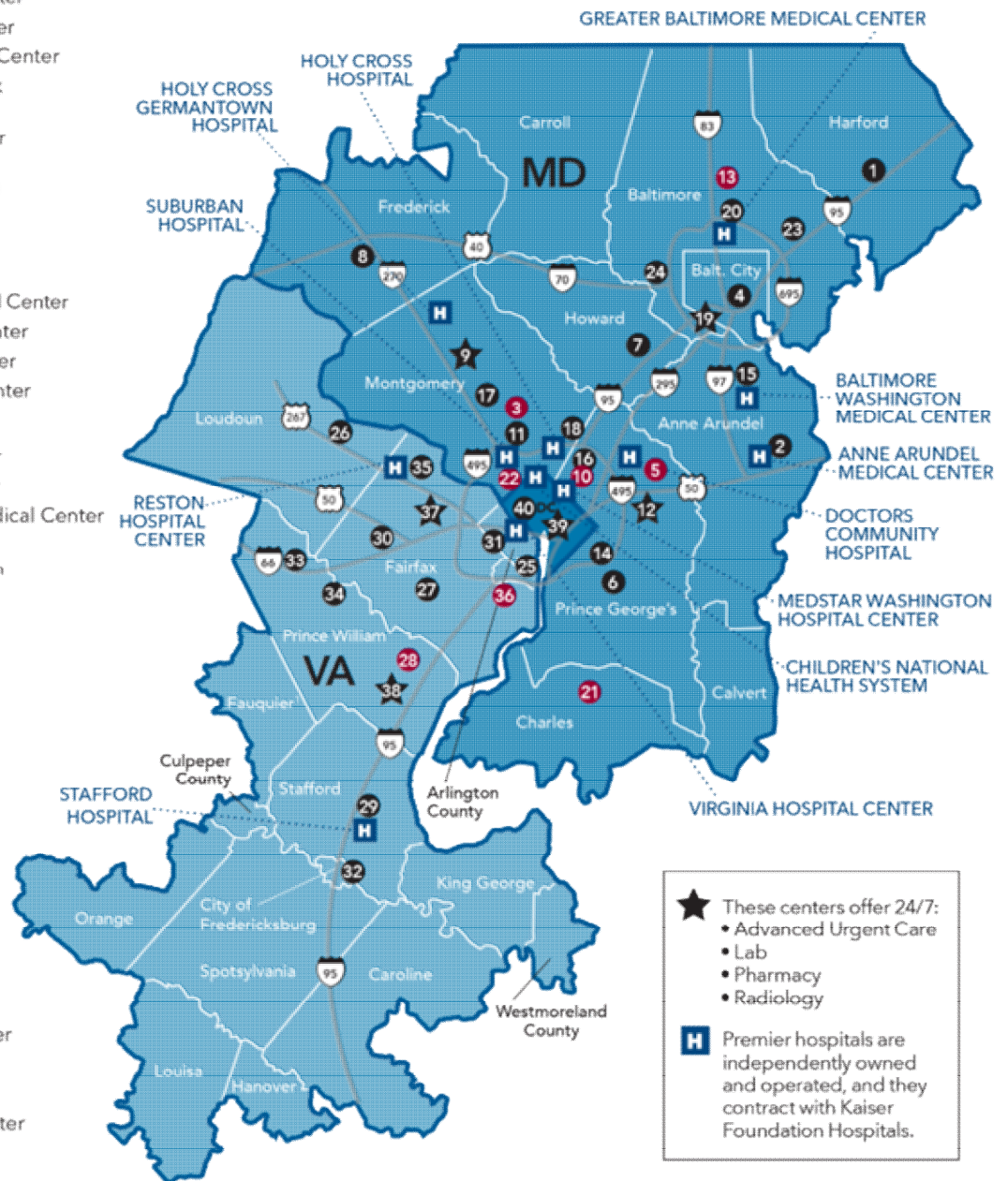
