Our PGY1 Managed Care Pharmacy Residency Program builds upon the PharmD education to develop managed care pharmacists.

Residents will learn to:

- Design and implement clinical programs to enhance the efficacy of patient care.

- Execute formulary management and health plan benefit adjudication.
- Provide direct patient care in chronic and specialty diseases.
- Lead and complete a longitudinal research project using data analytics.
